

FIRST AID POLICY

PURPOSE

To ensure the school community understands our school's approach to first aid for students.

SCOPE

First aid for anaphylaxis and asthma are provided for in our college's:

- Anaphylaxis Policy
- Asthma Policy This policy does not include information on first aid requirements for COVID-19. Our college follows the Department's operational guidance for first aid management relating to COVID-19.

POLICY

From time to time Mount Waverley Secondary College staff might need to administer first aid to students at school or school activities.

Parents/carers should be aware that the goal of first aid is not to diagnose or treat a condition.

Staffing

The College Principal will ensure that Mount Waverley Secondary College has sufficient staff with the appropriate levels of first aid training to meet the first aid needs of the school community.

Our college's trained first aid officers are listed in our Emergency Management Plan (EMP). Our EMP includes the expiry dates of the training. The college also has registered nurses who staff our First Aid Office on both campuses.

This list is reviewed on an annual basis as part of the annual review of our Emergency Management Plan.

First aid kits

Mount Waverley Secondary College will maintain:

- A major first aid kit which will be stored in the Sick Bay Office on both campuses
- The college also has a number of portable first aid kits which may be used for excursions, camps, or yard duty. The portable first aid kit/s will be stored in the Sick Bay Office on both campuses.

The School Nurse/s will be responsible for maintaining all first aid kits, ensuring they are managed in accordance with the Department's policy and guidance on first aid kits – refer to <u>First aid kits</u>.



Care for ill students

Students who are unwell should not attend school.

If a student becomes unwell during the school day they may be directed to Sick Bay and monitored by staff. Depending on the nature of their symptoms, staff may contact parents/carers or an emergency contact person to ask them to collect the student.

First aid room/sick bay area

Our school follows the Department's policy and guidance in relation to our sick bay area to ensure it is safe, hygienic and appropriately equipped: <u>First aid rooms and sick bays</u>.

First aid management

If there is a situation or incident which occurs at school or a school activity which requires first aid to be administered to a student:

- Staff who have been trained in first aid will administer first aid in accordance with their training. In an emergency situation, other staff may assist in the administration of first aid within their level of competence.
- In a medical emergency, staff may take emergency action and do not need to obtain parent/carer consent to do so. Staff may contact Triple Zero '000' for emergency medical services at any time.
- Staff may also contact NURSE-ON-CALL (on 1300 60 60 24) in an emergency. NURSE-ON-CALL
 provides immediate, expert health advice from a registered nurse and is available 24 hours a
 day, 7 days a week.
- If first aid is administered for a minor injury or condition, Mont Waverley Secondary College will notify parents/carers by a phone call.
- If first aid is administered for a serious injury or condition, or in an emergency situation, college staff will attempt to contact parents/carers or emergency contacts as soon as reasonably practical.
- If staff providing first aid determine that an emergency response is not required but that medical advice is needed, college staff will ask parents/carers, or an emergency contact person, to collect the student and recommend that advice is sought from a medical practitioner.
- Whenever first aid treatment is administered to a student resulting from a student incident, injury or illness, Mount Waverley Secondary College will:
 - \circ $\;$ record the provision of first aid treatment on CASES21, Compass and eduSafe Plus if applicable.
 - if care was provided in response to a medical emergency or reportable incident, follow the Department's <u>Reporting and Managing School Incidents Policy</u>, including reporting the incident to the Department's Incident Support and Operations Centre on 1800 126 126 where required to under that policy.

In accordance with Department of Education policy, analgesics, including paracetamol and aspirin, will not be stored at school or provided as a standard first aid treatments. This is because they can mask



signs of serious illness or injury. For further information refer to the Department's Policy and Advisory Library: <u>Medication</u>
